This correspondence will provide you with the billing rate for Peach Lake (Vails Grove) Sewer District during the 2015 calendar year. Please retain this information for your records.

For tax preparation purposes, your portion of the interest paid during 2014 on the debt for the sewer was \$387.12. Please consult with your tax advisor as to the deductibility of these costs.

For 2015, the sewer rates will remain the same as outlined below until a financial reconciliation and audit is completed with the Town of North Salem and NYS DEP. Once the Town has completed the reconciliation, determination on the rates will be completed which may result in an adjustment to your rate.

### **PAYMENT POLICY**

1. Payments received within 30 days of the billing date without penalty: due date is printed on the invoice. (Because the invoices were held up for several days, we will extend the deadline by 10 days for this First Quarter of 2013)
2. Accounts are charged a 5% late fee on current charges for late or non-payments.
3. Returned Check fee will be applied.

4. For accounts having a past due balance as of September 30<sup>th</sup>, the balance will be sent to Putnam County for levy on the subsequent year's property tax.
