The Proposed Action is Approval of Subdivision, Site Plan and Building Plans to develop a commercial recreation complex on portions of the Pugsley Road lands. The Proposed Action also includes Town approval of a land swap (transfer of ownership) of the subject land from Town to private ownership in fulfillment of prior approval of a Home Rule resolution adopted by the Town. Proposed Action encompasses development on approximately 81.78 acres of undeveloped land bounded by Pugsley Road, former Zimmer Road, and Fields Corner Road. An indoor recreation building and ten synthetic turf, fenced and lighted playfields are proposed.

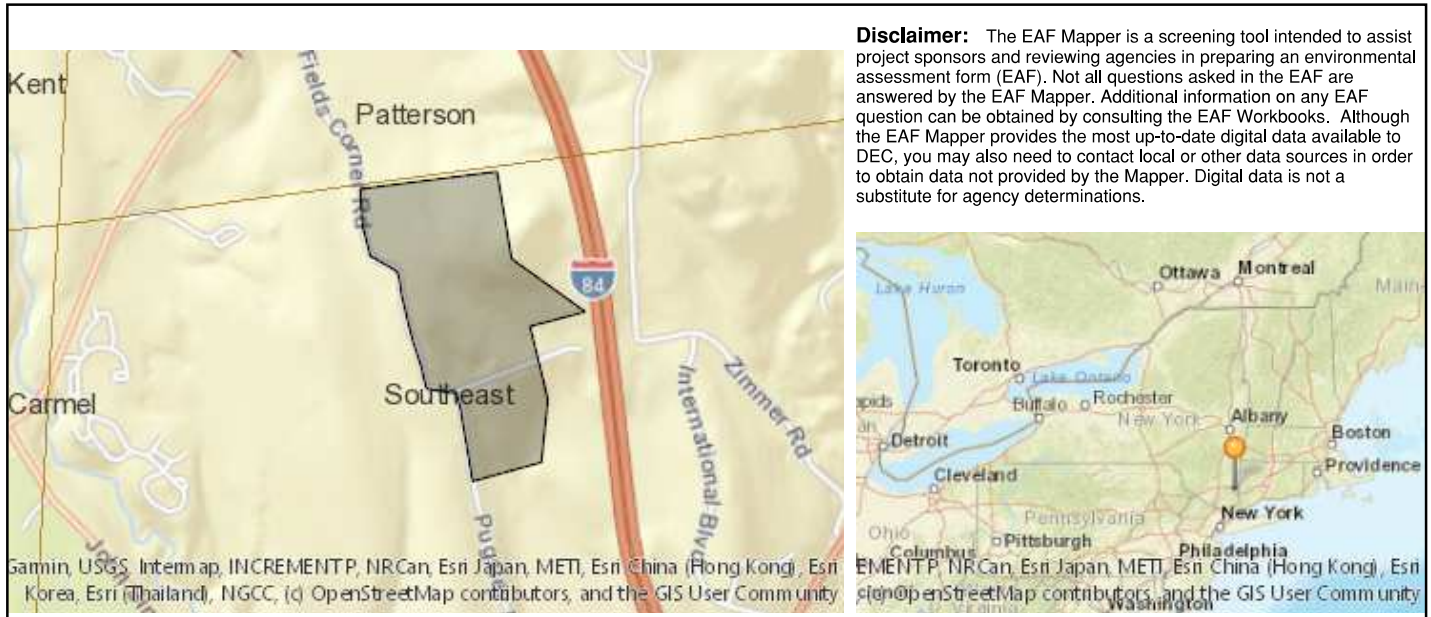

PROJECT DESCRIPTION

ProSwing Sports Realty, Inc. (the “Applicant”) proposes to construct a commercial recreation complex to include a 34,855-square foot recreation building, various smaller concession/restroom and maintenance buildings of 3,600 square feet or less each, nine synthetic turf fenced and lighted baseball fields with amenities, one synthetic turf multi-sport field, and associated utilities including two or more wells, a septic system, and stormwater management areas (the “Project”) on a +/- 82-acre property located at 160 and 132 Pugsley Road (the “Project Site”) within the RC Zoning District in the Town of Southeast (Tax Map ID 45.-1-10 and 11). A portion of the Project Site is located within the Ridgeline Overlay District. As part of the Project, a portion of Barrett Road/Zimmer Road on the east side of Pugsley Road would be widened, all of which are Town owned roads. As part of the Project, existing parcels 45.-1-10 (“Lot 10”) and 45.-1-11 (“Lot 11”) would be subdivided to reduce the overall lot size from 153.5 acres to 81.8 acres. Lot 10 would be reduced in size from 93 acres to 66.2 acres and Lot 11 would be reduced from 60.5 acres to 15.6 acres. The balance of the land would be retained by the Town. The Project would disturb approximately 46.6 acres, including 4.6 acres of Town of Southeast wetland buffer/controlled area. The Project requires site plan, subdivision, and wetland permit approval from the Planning Board, land swap approval from the Town Board, and several area variances from the ZBA.

POTENTIAL ENVIRONMENTAL IMPACTS

The Project has the potential to result in the following environmental impacts:

LAND USE, ZONING, AND PUBLIC POLICY

The Project would not require any zoning changes. The Project would increase the intensity of land use at the project site.

GEOLOGY, SOILS, AND TOPOGRAPHY

Construction of the Project would involve disturbance to slopes in excess of 15 percent, and more than 10 acres of land.

VEGETATION AND WILDLIFE

Construction of the Project would permanently disturb vegetated areas including elimination of woodland habitat.

WETLANDS AND WATER RESOURCES

Direct disturbance to wetlands on the property would be avoided however the Project will alter buffer/adjacent areas in several locations. Stormwater drainage would flow from stormwater management basins into these wetlands and downstream. The project site is located within the Middle Branch Reservoir basin of New York City's drinking supply watershed. This basin is designated as Phosphorus-Restricted by NYCDEP.

SOCIOECONOMIC CHARACTER, FISCAL IMPACTS, AND COMMUNITY CHARACTER

The project would generate new property and sales tax revenue to the Town, Putnam County, and New York State from land that is now wholly tax exempt. A modest increase in employment taxes would be generated by the project.

COMMUNITY FACILITIES

The project would create potential demand for additional community services such as police and fire. The project would respond to existing demand for recreational facilities in the Town, Putnam County, and the broader region.

CULTURAL AND AESTHETIC RESOURCES

The project site may have had the potential to host prehistoric or historic archaeological resources.

TRAFFIC

The Project would generate new traffic on the local roadway network.

AIR QUALITY

The potential for air quality impacts is associated with construction equipment and additional traffic on the local roadway network by workers and clientele, although below emissions permit levels.

NOISE

The potential for short term noise impacts is associated with construction equipment and periodically during project operation.

LIGHTING

The Project has the potential to result in light shining onto adjoining properties. The Project may result in lighting creating sky-glow brighter than existing area conditions.

INFRASTRUCTURE AND UTILITIES

Additional demand on infrastructure (roads) and utilities (electricity) could result from the development.

CONSTRUCTION

Construction of the Project may have temporary impacts on neighboring properties and the roadway network.
