RE: INFORMATION AND WATER RATE FOR 2026

This correspondence will provide you with the 2026 billing structure and rates for your Water and Sewer District. Please retain this information for your records.

For tax purposes, your portion of interest paid during 2025 on the debt for the water was \$43.58 and \$5.64 for the sewer district. Please consult with your tax about the deductibility of these costs.

WATER DISTRICT

For the Calendar year 2025, revenues were sufficient to meet expenditures.

The district paid \$46,852 towards the principal of \$558,914 of debt the district borrowed for capital improvements.

For 2026, the rates will be increased to compensate for inflation, electricity costs and prepare for future replacement of sand filters for the water plant.

The 2026 Operation and Maintenance Budget for the water system is \$435,900. The debt service budget is \$108,000. The budget is represented in the following components:

Prior to the January, April, July and October billings, water meters will be read to determine water use for each account. Your cost will be directly affected by your water consumption.

SEWER DISTRICT

For the calendar year 2025, revenues were sufficient to cover expenditures for the district.

The district paid \$12,208 towards the principal of \$67,696 of debt the district borrowed for capital improvements.

The 2026 Operation and Maintenance budget for the sewer system is \$507,250.

For 2026, the rates will be increased to offset inflation.

Payment Policy

1. Payments are due within 30 days of the billing date without penalty: the due date is printed on the invoice.
2. Accounts are charged a 5% late fee on current charges for non- or late payments.
3. Returned check fee will be applied for a return payment.
4. For accounts having past due balance as of September 30th, the balance will be sent to Putnam County for levy on the subsequent year's property tax.

Alerts and Notifications

Get alerts and notifications for service interruptions and emergency situations to your Special District. Take the time to sign up for notifications. It is a very simple procedure that only takes a few minutes to do.

Resident Safety / Security

Your Safety is our concern. Please know that the operators who take water meter readings do not usually ask to enter your home. Meters are read remotely from outside of your home.

The employee must have identification with them identifying them as a Town Employee or Representative of VRI, (contracted Operator). If anyone asks you to go into your home to read a meter or make repairs, you have the right to refuse them until you have confirmed their identity with a call to the Special Districts office at 845-279-8206 or the VRI office at 845-677-3839.
